GOLDEN BEACH BOY allowed to settle, gained a striking position three wide through the turn, bid on that path into the stretch, shook clear quickly and drew off under steady pressure. HOGUE mid pack, moved up three wide through the turn, came four wide to bid and closed well for the place, while no threat to the winner. COLLETON GARDENS mid pack and inside, moved up through the turn, angled out to bid four wide and ran evenly in the lane. RUN JAC RUN well placed inside, moved up and steadied into the stretch, angled out to bid three wide, then angled back inside and gained a share. NEARLY IRISH set the pace off the rail, drifted in slightly into the stretch, then faded in the drive. MR SUPERNOVA improved his position. SKIP THE ACT was a brief factor. LIL RED SPIDAMAN passed tiring rivals. HEAR THE MESSAGE vied for the lead on the inside, steadied on heels into the stretch, then faded. SIR TOBY showed little. OCEAN LANE PLAZA was outrun. A STEWARDS' INQUIRY AND A CLAIM OF FOUL LODGED BY THE RIDER OF HEAR THE MESSAGE AGAINST THE RIDERS OF GOLDEN BEACH BOY AND NEARLY IRISH, RESULTED IN THE DISQUALIFICATION OF NEARLY IRISH FOR

INTERFERENCE INTO THE STRETCH
