Footnotes

FOREVER VINDICATED raced close up early, bid out of the second turn, gained a short lead into the late stages then just lasted. DIANA'S VENDETTA was void of early speed, angled out six wide in the drive then was going well late outside. CONCORDE COUNTY was forced to take up in traffic early, rushed to the lead into the first turn then held on stubbornly on the lead to late before just hanging. LOUIE MONDELLO raced close up, bid outside the leader in the second turn then also continued well to late before hanging. SPEED LIGHTNING was well placed but lacked a strong late response. CAFE DES ARTISTES raced evenly. KATZIMO weakened after a half. MORE THAN LUCKY failed to menace. UNLIMITED showed little. POINTEDLY LEGAL was taken up early then stopped.
