Footnotes

KEYTOTHEPENTHOUSE stalked the leaders for six furlongs, bid four wide out of the second turn to gain a short lead then resisted gamely through a long drive before edging clear late. RACK EM UP looped rivals five wide through the second turn, loomed a threat through the furlong grounds then just hung late. COUNTY TRIAL raced boxed through the second turn into the stretch then made a mild gain once clear. ON THE FAN swung to the far outside out of the second turn then passed tiring rivals. WOLVSPA pressed the pace three wide, gained a short lead after five furlongs then flattened out. SILENT THUNDER failed to menace. IVARS BLUES was hard used pressing the issue and gave way after six furlongs. MAZOO LIAN GHOST weakened gradually. HEZA WILD GUY stopped. TALKMEISTER showed little.
