POINT JUDITH stalked the pace for five furlongs, bid outside the winner into the furlong grounds then shook clear late. CRYSTALLO was bumped by SHE'S NOTABLE at the break, raced well placed inside to the stretch, angled outside in the furlong grounds then was up for the place late. OPERA HALL set a moderate pace to the final furlong then weakened late. SHES NOTABLE came out to bump CRYSTALLO at the break, angled out five wide in the drive then made up some ground late. JILL GOLDEN raced evenly. CHANTY LIGHT was no factor. MY DAY WILL COME was through after a half. TAZETTA trailed. A claim of foul by the rider of SHES NOTABLE against CRYSTALLO for interference at the start was disallowed.
