Footnotes

RIZZI GIRL was void of early speed, fanned six wide in upper stretch to gain clear racing room then raced past the leaders to win going away. HASTY KISS was unhurried early, advanced through the second turn, found room between rivals to challenge through the furlong grounds but couldn't stay with the winner while outfinishing the rest for the place. A STAR ABOVE made a three wide middle move then loomed boldly outside through the furlong grounds before hanging late. PERSUADE set a slow pace to mid stretch then weakened. MEGAN'S CRACKER made a middle move to be in striking distance out of the second turn but failed to sustain that rally. RAKEEN LAKE chased early, bid after five furlongs then flattened out. NATIVE WAGER raced evenly. EMERALD ISLE failed to menace. WESTERN PUNCH checked up in traffic early then faded after six furlongs. TWISTED CORD stalked the pace to the second turn then stopped. The portable inner rail was set at 22 feet.
