WILLA CATHER made an inside middle move, bid inside out of the turn and finished willingly to outfinish the rest but couldn't reach the winner. FIRM REALITY bid three wide out of the turn then weakened in the final furlong. PRETTY GALORE swung six wide out of the turn then closed a gap late. P. J.'s ESKIMO passed tiring rivals. JAVA WIT failed to menace. VICTORY PROSPECT raced evenly. FEED FOR SPEED dueled for five furlongs then faded. BOXER GIRL wouldn't load then broke a step slow, was hustled along to the turn then came up empty. JENNASILPRINCESS showed little. BEACH BERTIE stopped. MARCO CAT was through early.
