PATRIOTIC DREAM made a middle move to the stretch, drifted well past the middle of the course then closed with a rush late to be up in time. DELIVERED pressed the issue from the outset, shook clear in the second turn then drifted in under pressure in the drive before hanging late. FLORIDA HOLIDAY was hustled along to a striking position, bid in the second turn, angled inside in the drive then steadied briefly in the furlong grounds before also hanging late. SOUL OF THE MOON made a mild gain late. ANONYMOUS DONOR passed tiring rivals. CHANNELOFDREAMS raced evenly. SOBRIETY failed to menace. BLUEMOONINYOUREYE was used up on the lead. PLAUSIBLY showed little. There was a stewards inquiry and claim of foul by the rider of FLORIDA HOLIDAY against DELIVERED for interference in the stretch but was results were permitted to stand as posted.
