SATISFIED MIND stalked the pace early, bid four wide leaving the turn then after dueling to late, edged clear and prevailed. KENTA KUN was shuffled back inside into the turn, recovered to get through along the rail after a half, drew up to the leaders leaving the furlong grounds but hung late. UNO WAY CALLE dueled to late before hanging. MAN OF FAITH made a middle move out of the turn, fanned five wide in the drive but was outkicked late. HE'S ONE FOR ONE dueled to upper stretch then slowly weakened. TREASURE HUNTER raced evenly. MISTER ALIMONY also turned in an even effort. CODE RUNNER failed to menace. ZIPPER showed little. APOLLYONCOMESFIRST stopped. SEEM'S TO BE also stopped.
