**Footnotes**

VIDLOCITY stalked the pace inside, split rivals while rallying through the furlong grounds and was up late under strong handling. FINAL DISCOUNT broke sharp to set a moderate pace under good handling, resisted the winner to late then hung while best of the rest. SNIFFLES raced close up from the outset, attempted to collar the leader out of the turn to mid stretch then weakened late. CHULA made a three wide middle move but failed to sustain that rally late. LA NINA DANCER raced evenly. SONG OF NORA was well placed for six furlongs then faded. OUT OF DOUGH raced close up three wide for six furlongs then also faded. DANCE OF JOY failed to menace. RADIANT NANCY showed little. SHEBAKAYSKITTYCAT trailed. The portable inner rail was set at 22 feet.
