LAWYER JEN broke sharp, set a fast pace while removed from the inner rail then slowly drew off through the late stages. CONGOTOWN chased the winner four wide to mid stretch then weakened while besting the rest. BRINCA stalked the pace five wide to mid stretch then failed to respond. JUST PICK ME made an inside middle move, bid in the furlong grounds then gave way. ERASER failed to menace. HELEN'S TROLLIE showed little. HOT CHILI PEPPER was fractious in the gate then trailed.
