U F STORMY APPEAL bore out at the start bumping with TRIPLE SPENDING, rushed up to make the lead, set the balance of the pace and prevailed under strong handling. GARDEN GIRL checked a bit going down the backside, was allowed to settle, then finished full of run when set down to just miss getting up in time. TRIPLE SPENDING was bumped by the winner leaving the gate, went up to be with the pace and was steadily gaining ground to also be narrowly beaten. TRULY BRIGHT broke sharply to prompt the pace until late stretch was brushed by GARDEN GIRL and carried out by that one then weakened only slightly. FOCUS GIRL was outrun. MISS SUWANNA showed little. SMALLCIRCUMFERENCE dueled for the early lead and flattened out.
