CAT'S SIGN vied for lead, between horses, weakened, mid stretch, held well THE SHORT STUFF allowed to settle, mild bid, no threat, passed tiring rivals. SALLE GARDEN stalked pace, 3 wide, no rally. PUDDLES REFLECTION middle of pack, early no threat. DANCER'S DEFENSE well placed, gave way, through after half. MARCY'S HOPE trailed, outrun. JENN IN THE CHASTE a schelded starter was ordered scratched by the stewards on the advice of the track veterinarian.
