MAGNIFICENT SKY dueled for the lead while being carried out by THE BIG MAN, shook clear once in the stretch and was all out to hold SONNY'S MEMORY safe. SONNY'S MEMORY settled just off the leaders into the stretch, rallied determinedly along the inside and just missed. NAMESAKE dropped back between horses after a sharp beginning then went evenly. THE BIG MAN went up to set a pressured pace soon after the start, was well handled while getting out, had speed into the stretch then weakened. DEVILS LUST was through after a half. SICKY NICKY trailed. The rider of NAMESAKE lodged a claim of foul against the riders of MAGNIFICENT SKY and SONNY'S MEMORY for alleged interference leaving the chute. After reviewing the video tape replay the stewards took no action.
