BENNYFAX was allowed to settle early, rallied in the upper stretch four wide, closed stoutly and drew off under strong handling. WICKED KAMIKAZE dueled early, gained a clear lead on the turn, was no match late for the winner but held place. NATIONAL SECURITY in hand early, rallied in the stretch five wide, finished well and was gaining. NEWYORKJOE contended throughout, lacked a late kick and went evenly. HARBOR JUNIOR hopped at the start, raced mid pack throughout and went evenly. SKY KERRIDGE set the early pace for a half, gave way in the stretch. BRACKINKNOWSALL allowed to settle, failed to menace. STREAKIN FOR CASH close up for a half, weakened in the lane. APPEAL THE VERDICT had no speed and was outrun. WE BEEN SPOTTED flashed brief foot and was through early.
