POR SUPUESTO set a pressured pace from the start, drifted entering the stretch, was quickly righted, matched strides with the winner until deep stretch under hard left handed urging and finished second best. DON'T HANG UP outrun early, found his best stride too late. GAITERO offered a mild bid on the second turn then finished evenly. MOJAVE HAWK went evenly. STEADY SMILER failed to reach contention. WILD CHARGER settled mid pack the failed to offer a closing response. CRYPTO'S APPEAL was never involved. B. Z. JONES had brief speed. MISTER MEADOWLARK was through after a half. PINE CLUB disputed the early pace and stopped.
