Non-Winners of \$100,000 twice at a mile or over in 2002 allowed 2 lbs; of \$100,000 at a mile or over in 2002; 4 lbs; of \$100,000 at any distance 6 lbs; of \$50,000 at any distance 8 lbs. (MCOS not considered in weight allowances). In the event more than fourteen (14) entries pass the entry box by 10:30 A.M. Eastern Standard Time, Wednesday July 17, 2002, preference will be given to those horses having accumulated the highest lifetime earnings at the time of closing entries. Lifetime earnings will be determined according to statistics provided by Equibase. Closed Monday, July 8, 2002.

MAGIC WEISNER prompted WISEMAN'S FERRY while remaining along the rail until the second turn, angled outside of that one on the middle of the second turn, was herded out when the pacesetter drifted, rallied determinedly through the stretch and proved best under energetic handling in a stretch-long drive. WISEMAN'S FERRY made the lead soon after the start, set the pace while remaining off the rail, drifted out entering the stretch despite strong right handed urging and just missed hanging on. THE JUDGE SEZ WHO trailed into the stretch, rallied steadily along the rail and finished with good courage. PEEKSKILL settled just off the pace for six furlongs, rallied three wide entering the stretch, was also carried out and finished willingly.
