### Footnotes

M G PRINCE dueled on the lead under mid stretch, drew off late under brisk left handed urging. JOY OF BAPTISTRY dueled with the winner until mid stretch, could not match strides late but was second best. SHARP DANCER allowed to settle early, swung wide and had a mild bid. DIAMOND APPEAL never far back, drifted out in the stretch and lacked a late response. CHIPPED chased on the inside for a half, then tired. BLUEGRASS JOE was outrun. EL ALTANERO broke slowly and showed little.
