**Footnotes**

CALL ON JOSHUA was never far back, angled out five wide in the upper stretch, closed determienly and wore down his rivals. FLASH OF LIGHT had good position, rallied four wide in the stretch and was up for second. SAINTHORATIO dueled on the lead, gained a clear lead in mid stretch, weakened in deep stretch. GRIDIRON KEY vied for the early lead, went evenly in the stretch. BEHRLY JUMPIN was allowed to settle, improved position while no threat. RA'A ACTION never far back, rallied on the second turn, put in his bid, then flattened out. GENERAL LAFAYETTE was never a threat. FINAL RULE set the early pace, stopped.
