WIN FOR JOE GATES pressed the pace and dueled on the lead while three wide, drew clear in late stretch under strong handling. WEST LONG BRANCH dueled on the inside until mid stretch, could not match strides with the winner late but was second best. MARCO REGS WINNER set the early pace, dueled on the lead until the second turn, then flattened out in the stretch. TRAVEL DUE STAY allowed to settle, failed to menace. BROADWAYTYLERBEAU offered little and was outrun.
