TALE OF THE COURT dueled early while three wide, drew clear at the quarter pole, widened through the lane while being ridden out. LARGEDOUBLEDOUBLE was never far back, rallied four wide in the stretch and was up for second. CHASINTHATMONKEY had good position, rallied at the quarter pole, put in his bid, then hung. DR. FRANKLIN never far back,had a mild bid on the inside. SUNSHINE BOB allowed to settle, improved his position on the inside. ARRESTEDBYMISTAKE raced middle of the pack and went evenly. DOUBLE NAUGHT SPY allowed to settle, failed to menace. HOOTEN'S RIDGE dueled early on the inside, tired. ELECTRIC BILL dueled while between horses, tired in the stretch. ENCROACHMENT was outrun. BANDON showed little while racing five wide. WINDING LANE was through early.
