### Footnotes

PERFECTLY PLAYED never far back, rallied the upper stretch, slipped through on the rail, drew clear in late stretch under strong handling. BUZZ BUNNY never far back, angled out in the upper stretch, closed willingly and was second best. GOLD RUSH CASEY well placed down the backside, rallied in the stretch to gain a slight lead, then was outfinished. O'RIAIN set a pressured pace, then weakened. KING CRUZ never far back, lacked a late response. TAKE AHIKE MIKE dueled for the lead until the top of the stretch, then gave way. MUSICAL D J showed little and trailed. The rider of BUZZ BUNNY claimed foul against the rider of PERFECTLY PLAYED for alleged inference at the three eights pole. After viewing the video tape the stewards took no action.
