NORMANDY MILLS was never far back, rallied through the stretch to close willingly and be second best. SLEW SLAMMED SUE was well placed, lacked a late response and went evenly late. DAKOTA'S CHOICE set the pace and pressed the pace, weakened through the stretch. SAVTHELASDANCEFOME was never far back, went evenly. IM FOR LEXI was in the middle of the pack and no threat. READY TO FIGHT failed to menace. MR. BUCKEYE was no factor. MAJESTIC COURT slow early was outrun. JOHNNY C was outrun.
