FOREST PICNIC hopped at the start, went up to prompt the winner before a quarter, chased that one all the way and finished clear for second. CLEVER JIMMY C went evenly while no threat. MERCER'S COOL CAT had speed for five furlongs and weakened. LADY DELPHINUS failed to reach a contending position. U B THE JUDGE was always outrun. WHITEWATER WAY bore out a bit at the start and offered little thereafter. BUCKEYE TEDDY was through after a half. DINKERS GOOD NEWS trailed.
