LORD RELINCHO dueled for the early lead through quick fractions, shook clear on the turn, lasted late while lasted fully extended. ATLANTIC RIDER stalked the pace, rallied three wide in the stretch, finished well and was gaining. DANCE THE CHA CHA was allowed to settle, saved ground in the stretch and finished willingly. SILENT LEDGER stalked the pace, rallied five wide in a good effort. BACON AND RICE outrun early, found his best stride late and made up ground. MY MARACAS BAY well placed throughout, had no bid and went evenly. FLYERS REWARD never far back, lacked a late response. PLAY THE MARKET vied for lead, tired in the stretch. SALT wide early, was always outrun. FIXED OPS trailed. The rider of ATLANTIC RIDER claimed foul against the rider of LORD RELINCHO for alleged inference leaving the gate. After viewing the video tape the stewards took no action.
