SCHOOLMISTRESS never far back, advanced in the two path on the turn and into the stretch, made the lead at the eighth pole and drew clear under right handed urging. SNOWSCAPE prompted the pace in the three path and finished clear for second. KAYLE PRINCESS made the lead quickly after the start, set the pace until mid stretch then weakened. TOP TOUCH failed to menace. EVE THE DANCER was no factor. PYRITE MARCI was a sharp threat three wide for a half then gave way. The rider of SNOWSCAPE lodged a claim of foul against the rider of the winner for alleged interference entering the stretch. After reviewing the video tape replay the stewards took no action.
