COLD TRIAL dueled on the lead for seven furlongs, drew off in late stretch under strong handling. PREACHER BUCK dueled with the winner, could not match strides late but was second best. ITS BINALONG TIME slow early, rallied in the upper stretch, four wide and closed willingly. BLUES CROSSING had good position three wide, lacked a late kick and went evenly. MR EASY E contented for six furlongs, lacked a late response. RIGHT ON well placed and saved ground, tired in the stretch. KYLE DRAWS ACES was no factor.
