GREAT DEBATER away alertly, set all the pace and maintained his advantage under brisk handling. MAGESTIC HEART prompted the pace two wide all the way, came out late under left handed pressure and finished second best. QUICK CASH stalked the pace three wide into the stretch, was shut off late and finished with good courage. CODE RUNNER well placed, lacked a closing response. R B ENCORE failed to menace. MR. CONCLUSIVE trailed. The rider of QUICK CASH lodged a claim of foul against the rider of MAJESTIC HEART for interference in deep stretch. After reviewing the video tape replay the stewards took no action.
