KING OF T MOUNTAIN had speed from the start three wide, was carried wide entering the stretch, made the lead at the eighth pole and edged clear under a hand ride. ROYALDISH had speed from the start and finished with good courage along the rail. TALE OF THE COURT washy in the post parade, sprinted up along the inside to make the lead before a quarter, set a pressured pace into the stretch, drifted out at the three sixteenths pole then faded. MR. ZARROW failed to menace. ALPHA BEAR bobbled a bit a few strides out of the gate then trailed.
