FIREONTHEWIRE never far back, advanced steadily three wide, sustained his rally through the stretch and was along in time. BAD SERVICE sprinted up along the rail to make the lead just after the half mile pole, set the pace until deep stretch then could not handle the winner. GOLD PROSPECT slow early, closed a gap late outside. CODE RUNNER passed tiring rivals. BIDDY'S LAD made the lead a few strides out of the gate, set the pace the opening quarter, had speed into the stretch then weakened. VICTORY CURE well placed, failed to offer a response. PREMIER COURT had brief speed. JEROBOAM was through early.
