Footnotes

PLANT CITY RED chased the pacesetting HOLY FIT into the stretch, made the lead two wide before the eighth pole, drifted out under strong left handed urging inside the sixteenth pole and was all out to prevail. WHERESTHELIMIT never far back, offered a bid four wide into the stretch, was forced out late by the winner and just missed in a game effort. LUCKYLEAD settled just off the leaders along the rail, angled out three wide at the top of the stretch, drew to the leaders then was shut off inside the sixteenth pole causing his rider to check hard. HOLY FIT sprinted to a clear lead soon after the start, set the pace until the top of the stretch then weakened late. LEFT IT IN VEGAS failed to menace. FORSTER HALL lacked a closing response. REPRISAL was outrun. The stewards posted the inquiry sign and the rider of LUCKYLEAD lodged a claim of foul against the rider of the winner for interference in deep stretch. After reviewing the video tape replay, the stewards disqualified PLANT CITY RED and placed him third.
