CLAIM FORM allowed to settle, rallied on the second turn four wide, drew off quickly through the stretch to win in handy fashion. SHOALIHS TALE never far back, rallied in the stretch, while no match for the winner was up for second. REDEMPTION SONG pressed the pace and vied for the lead, then weakened in the stretch. BLISS LANDING was well placed, lacked a late response and went evenly. LOCKER allowed to settle, rallied at the quarter pole to draw even, then failed to sustain his bid. AWE taken back early, was no factor. CAST NO SHADOW never far back, failed to menace. COURT APPEARANCE set the pace and dueled for the lead, then dropped back.
