INSPECTOR MORSE was never far back, rallied at the three eight pole and split horses, drew clear in the stretch under strong handling. STONE EAGLE dueled three wide, was outfinished late but held well and was second best. MUFASA CAT well placed and saved ground, steadied at the three eight pole on the rail, dropped back on the second turn, came again in the stretch. MY KNIGHT INDEED vied for the lead four wide, came up empty in the stretch. LUNA DE LOBO allowed to settle, failed to menace. JACKSON ON TOUR had good position for three quarters, gave way in the stretch. HISTORIAN showed little and trailed. THE RIDER OF MUFASA CAT CLAIMED FOUL AGAINST THE RIDER OF INSPECTOR MORSE FOR ALDEGED INTERFERENCE AT THE THREE EIGHT POLE. AFTER VIEWING THE TAPE THE STEWARDS TOOK NO ACTION.
