### Footnotes

COLD TRIAL close up from the start three wide, responded readily when set down entering the stretch, made the lead just inside the eighth pole and won under brisk handling. GOLD RUSH CASEY disputed the pace all the way and gamely gained second. SCHOOLMEISTER close up three wide, ducked in nearing the three eighths pole then rallied late. REGGIES CAT set a pressured pace until mid stretch then weakened. BABA BOOEY close up along the rail, was shut off entering the turn causing his rider to check hard, lost stride and dropped out of it. MUSIC FAN was through early. DINKERS CLASS ACT trailed. The rider of BABA BOOEY lodged a claim of foul against the rider of SCHOOLMEISTER for interference entering the turn. After reviewing the video tape replay the stewards disqualified SCHOOLMEISTER and placed him fifth.
