SKIPPY DUE reserved for a half, responded readily when set down entering the stretch in the five path, made the lead late and drove clear. JODY'S POWER prompted the pace two wide into the turn, made the lead just past the three eighths pole, set the balance of the pace and opened a clear advantage into the stretch then could not handle the late charge of the winner. DAZZLE ME DANNY settled just off the leaders along the inside, bid in the three path entering the stretch then leveled off. BROTHER BRETT failed to menace. ROBYNS AFAIRE away from the gate slowly, was taken wide leaving the chute and failed to reach contention. NAMESAKE was outrun. MYASTORM set the pace along the inside into the turn, had speed until mid stretch then tired. SHOWMANSHIP was also taken wide early and was through early.
