REDO THE COURT was well rated behind the speed, rallied at the quarter pole on the rail with a quick move, drew off in the stretch under brisk handling. THREEWISEMEN was unhurried early, rallied four wide in the stretch, finished well and up for place. POR SUPUESTO stalked the early pace, rallied at the quarter pole three wide and drew even, weakened in late stretch. BABA BOEY unhurried early, passed tiring rivals while no threat. FLASHY'S BRO allowed to settle, failed to menace. UBETIMFAST hard used early to make the lead, tired after a half. DUKE SKYWALKER flashed brief foot on the rail and was through early.
