**Footnotes**

COUNTRY FOX bore out at the start, settled close up, was in tight between horses on the middle of the turn, responded full of run five wide through the stretch, made the lead late and drew clear. WHOLESAL was shut off a few strides out of the gate, dropped back then was taken ten wide, made the lead with a quick move just after a quarter, drew clear on the turn, set the pace until deep stretch then could not handle the winner. WICKED WANDA prompted the early pace then was outfinished. THE SHORT STUFF failed to menace. OHIO VOLUNTEER had brief speed. BUCKEYE BOUND trailed into the stretch, swung widest of all and was not a threat. MARCY'S HOPE flashed early speed. LIGHT ONE was through early. THIS COULD BE IT was no factor. DANCER'S DEFENSE made the lead shortly after the start, set the pace until just past the half mile pole, had speed into the stretch then stopped.
