OHIO VOLUNTEER stalked the pace, rallied on the second turn, drew off in late stretch under right handed pressure. POLAR VIXEN unhurried early, rallied in the stretch, put in a strong bid, then was outfinished. LEVEL BID taken back, had a steady advance while no threat to the top two. PHANTOM'S MAGIC in the middle of the pack, was no factor. DARK RAINBOW well placed, flattened out in the stretch. CRUCIAL POINT set the pace and had a clear lead, then faded on the second turn. LEAVIN' STEVEN chased for five eight's, then gave way. DANCER'S DEFENSE was through after a half.
