### Footnotes

SHINY DANCER set the pressured pace off of the inside, shook clear through the turn, dug in to meet the challenge and gamely led throughout. TEMPESTUOUS SQUALL pressed the pace along the inside, battled through a prolonged drive but was unable to best the determined SHINY DANCER and settled for the place. MAUI SUNSET prompted the pace between horses, dropped off of the pace through the turn, angled out entering the stretch, came again and was gaining with every stride. Z Z POP contended between horses, came five wide and improved her position through the lane. JAMIE'S MAMBO was hustled along between horses, bid four wide entering the stretch but weakened during the drive. BUBBLE BERRY made a middle move five wide, offered a mild bid but failed to sustain the drive. IRISH VISION was forwardly placed along the inside to the turn and faltered. COAX ME HEIDI trailed.
