### Footnotes

CASTLEPOST tracked the pace three deep, took over entering the stretch and quickly drew away. KOWBOY KODY attended the pace along the inside, shifted out leaving the turn and stayed on fairly well to earn the place. SEVEN DAY FOOL was allowed to settle, circled five wide through the turn and was along for the show. MAXOPICO was unhurried into stride, came four wide and improved position while failing to threaten. BLUE TIE AFFAIR was allowed to settle, got through toward the inside entering the stretch but lacked a response when called upon. LEX INCLUDE showed little. BLUEMOONINYOUREYE saved ground to no avail. LORD CANELA opened clear to set the pace, was collared leaving the turn and stopped once headed.
