**Footnotes**

HANCHO outrun early, advanced off the inside on the turn, split rivals in midstretch and closed willingly to be up in time. Z APPEAL outrun early, commenced his rally four wide on the turn, angled to the outside for the drive and closed fast. LUMPY'S ACE within striking distance, moved up six wide on the turn, challenged inside the final furlong, gained a short lead but was outfinished. BE ME vied for the lead off the inside and weakened. WILLBRITTE drifted in at the start, was outrun, raced off the rail on the turn, angled out once in the stretch and improved his position late. CHEAPER TO SETTLE forced the pace three wide, drifted out a bit in upper stretch and tired. KITCHENMAN alternated for the lead along the inside, tired and dead heated with TALE OF LUCKNFAME. TALE OF LUCKNFAME behind the leaders, race in the five path on the turn, gave way and finished in a dead heat with KITCHENMAN. MY DOMINICK JAMES forced the pace four wide, held on well to the stretch and faded.
