SON OF THE SUBLIME pressed the pace three wide, challenged before a half, took over after six furlongs, drew off then was kept to the task. D'ARIO outprinted early, made a run four wide on the second turn and finished willingly late to be second best. MOBY S forwardly placed four wide, held on well to the stretch and tired. LOU COLLEGIATE outrun for a half, improved his position while no threat. IDEOLOGIST in tight when bumped at the start, was outrun early, could not menace. DEWISE unhurried along the inside, was no factor. KRIS GOT CROSSED was no threat along the inside. PARK AND FLY forwardly placed in the two path, stopped. CARSON KID bumped at the start, had seed for a half inside. COCKEYED JUSTICE set the pace off the inside, moved to the rail on the second turn and stopped. HAM I AM failed to menace.
