COMMADORE KATE was allowed to settle, advanced four wide, poked her head in front with a furlong to run and held stubbornly through the drive. NEON LIPSTICK settled in hand four wide, moved with the winner through the second turn, finished willingly but wasn't quite good enough. COUNTRY SINGER set the pressured pace, was headed with a furlong to run, weakened but had enough left to hold the show. VEILED VOW was allowed to settle, made a mild rally between rivals and improved position. SASSY KRISTINA was slow into stride, angled out to make a late rally but failed to seriously threaten. FILLAZZENE pressed the pace two wide to the stretch and faded. LADY JAMEELA raced wide throughout and was never a factor. LIL DOTTIE was forwardly placed five wide for five furlongs and retreated. BELIEVE IT HONEY contended along the inside for six furlongs and dropped out. SILVER MARINA was outrun.
