DIXIE DECISION close up from the start, bounced around between rivals midway through the second turn when attempting to split rivals, angled out once in the stretch and closed willingly to be up in time. PASCAL reserved while within striking distance, advanced four wide on the second turn to challenge, took over in midstretch and held on gamely while not quite good enough. SOCKS forwardly placed three wide, was bumped by the winner midway through the second turn then weakened. NAFASS unhurried early, angled out on the backstretch, made a four wide middle move but could not sustain the bid. PROMISED PROMISE alternated for the lead off the inside and tired. MEISTERWERK close up early, moved four into the stretch and gave way. ASMODEUS vied for the lead inside, was bumped by the winner midway through the second turn and was pulled up soon after.
