SISTER GENEVRA tucked in to save ground while never far back, worked her way out through the second turn, kicked on well, reeled in HEAVENLY LIGHT in the final yards. HEAVENLY LIGHT stalked the pace three wide, took over entering the stretch, opened clear and kept on well but was unable to resist the winner. BOOZY BIRD opened clear to set the pace, was collared entering the stretch, gave way but had enough left to hold the show. WITTY AND WISE was unhurried into stride, circled six wide and improved position through the stretch. ACACIAN SPIRIT settled saving ground, was bottled up leaving the second turn, steadied near the quarter pole found room between horses and was making up ground. LADY OF RIVENDELL settled between horses, ranged up to make a mild bid but lacked the needed late response. OCTOBER SONG was close up four wide to the stretch and faded. KITTEN'S HOUSE broke slow, was unhurried into stride, finished with a belated gain but failed to threaten. WINTER'S CHILD was allowed to settle, moved up six wide to make a mild bid but failed to sustain the drive. MISS ZIGGY showed little. FRENCH SADIE failed to respond. MINON was through early.
