### Footnotes

LADY SEATTLE stalked the pace three wide in hand, drew even leaving the second turn, wore down the pacesetters and edged clear. SEPTEMBER CEREMONY pulled to the fore to set the pressured pace, kept on well through a long drive but was unable to match strides through the final furlong. NEON LIPSTICK bobbled at the start, settled saving ground, got through and was along for the show. MODEL'S MEMO was allowed to settle, circled five wide to make her bid but failed to sustain the drive. OSCAR DE LA THORN prompted the pace two wide, disputed the issue to the stretch, but weakened between rivals and faded. KENTUCKY KITTY settled between horses but lacked a response when called upon. CUZSHEZAWESOME showed little.
