Footnotes

HAPPY KARMA set the pressured pace between horses, opened clear on the turn, settled into the stretch clear, then was all out to just last. MY GLITTER GIRL settled between horses, swung to the outside entering the stretch, finished well and was getting to the winner with every stride. CASTLE DREAMER was allowed to settle, moved up five wide to make a mild bid entering the stretch but lacked the needed late response. SQUAW CREEK SLEW was unhurried, swung seven wide leaving the turn and improved position through the stretch. ADDAGIRLADDY contended along the inside, shifted out and finished with a mild rally between rivals. VERNA MARIE made a belated gain between foes but failed to threaten. WIND KISSED was hustled along three wide for a contending position but weakened entering the stretch and faded. ORIENTAL CAT failed to respond. L. A. EXPRESS contended between horses for a half and retreated. STRIKE N FLY showed little. TROPICAL DELIGHT was forwardly placed inside, jumped tracks and lost action, came up empty leaving the turn and dropped out. ALL TOO IMPRESSIVE stumbled at the start and unseated her jockey.
