Footnotes

PLINKING forwardly placed early three wide, moved in a bit when moving closer on the second turn, responded willingly when sharply roused in the stretch and drew clear late. FORTUNATE HONOR sprinted clear, set the pace near the rail but could not last. OH MY GOODNESS reserved on the rail, split rivals once in the second turn, angled out in upper stretch but had no late bid. UNANSWERED PRAYER within striking distance early five wide, moved in to the four path on the second turn and tired in the drive. SONOMA COUNTY outrun early off the inside, was no factor. CLEAR TALKING GIRL close up early in the two path, moved to the inside for the second turn and faded. MISS COMSTOCK four wide early when forwardly placed, angled in to the three path on the second turn and stopped. MILLENIUM MAGIC was no factor.
