Footnotes

ABOVE THE CURVE settled saving ground, moved into contention on the second turn, steadied in traffic inside the quarter pole, got through nearing the furlong marker and quickly drew away once clear. SIR P. T. CHALONE broke slow, made a steady advance five wide but was unable to match strides with the winner late. ROYAL PADDY was allowed to settle, swung seven wide entering the stretch and was just up to earn the show. GRAND PIANO MAN was unhurried into stride, came five wide and finished with a mild rally. GHOST TIME tracked the pace three wide, drew even leaving the second turn, but weakened between rivals in the drive. WICKLOW COUNTY stalked the pace, made a bold bid four wide, forged a narrow lead a furlong out but failed to sustain the drive. MAJOR WINTERS failed to respond. TOUCH ME QUICK prompted the pace three wide to the stretch and faded. RIDGE CITY settled between horses and lacked a response when asked. TASTEFORCHAMPAGNE was rank to place early and was always outrun. ESPRESSO JOE contested the pace along the inside for six furlongs and stopped. NAVAJO PARK was through after a half.
