### Footnotes

SLICK PARDONED ME settled in hand toward the inside, advanced between horses on the turn, angled to the inside nearing the quarter pole, got through entering the stretch, shook clear and held sway. MOMENTS NOTIZ attended the pace four wide, was unable to match strides with the winner but kept on well to earn the place. PURELY BOY was allowed to settle, angled out six wide and made a late rally to earn the show. PLASMA BEAM disputed the pace off the inside, but faltered between horses entering the stretch and faded. CASE CLOCKER was allowed to settle, circled six wide but lacked the needed late response. BIG FLIRT contended five wide to the stretch and tired. CASTLEPOST was forwardly placed between horses through the turn and retreated. IVY CONNECTION was forwardly placed along the inside for a half and dropped out. WINKATDAWAT vied for the lead three wide for four furlongs and stopped.
