WHATTHECATDRUGIN sprinted clear, set the pace near the rail, drew off into the stretch and was not menaced while kept to the task. CHALICE outrun early, advanced inside on the second turn, angled out a bit for the drive but lodged only a mild late bid. DAYS RIDE five wide on the first turn when within striking distance, moved in a path on the second turn and lacked a late bid. CHIRAC forwardly placed three wide, gave way and was vanned off after galloping out. RED ALL OVER prominent off the inside, stopped. STRONG APPEAL within striking distance four wide, stopped.
